Project Brief

With the European Pattern Committee downgrading the Queen's Vase, held at Royal Ascot, from Group 3 level to Listed and putting the Group 3 Bahrain Trophy, also restricted to three-year-olds and held at Newmarket's July meeting, on the 'at risk' list, there is a concern among both the Thoroughbred Breeders' Association (TBA) and the British Horseracing Authority's (BHA) Race Planning Committee that the staying Pattern and Black Type programme (run over 12 furlongs plus) is under threat. As a consequence the TBA commissioned this review into the racing and breeding programmes of the stayer in Britain.

Executive Summary and Overview





Executive Summary

- Britain's staying programme is one of the strongest in the world and makes up an important part of the sport's heritage, but there have to be concerns that the British stayer is in decline.
- There has been a decline in the three-year-old stayer, which has contributed to the downgrading to Listed level of the Queen's Vase by the European Pattern Committee.
- With National Hunt breeding so reliant on top-class, smart middle-distance and staying performers, there will, in time, be drastic implications for National Hunt racing, which makes up a large proportion of the British and Irish racing industries.
- With a substantial number of small British breeders running their operations at a loss, it is inevitable that the more precocious sires will dominate. This has led to less sires standing in Britain with staying influences as they have lower appeal in the heavily dependent commercial marketplace.
- There need to be more incentives to encourage British stallion studs to stand and breeders to use sires capable of producing high-class stayers.
- British racing should re-examine the race programme for stayers and consider incentives to owners to race and keep stayers in training in Britain.
- More opportunities for fillies and mares races might also be considered, particularly in order to encourage more staying mares in Britain's broodmare population.
- Adjustments could be made to the Pattern and other races. Examination of the placement of the St Legers (Gr 1) in Britain and Ireland and the timing of the British Champions Long Distance Cup (Gr 2) and the Prix Royal-Oak (Gr 1) are two instances.



Consequences of Decline

If the British breeding and racing programmes for stayers are allowed to decline, the consequences will be serious.

- British racing's diversity, for which it is world renowned, would be significantly jeopardised.
- There will be an adverse effect on the families and pedigrees that make up a vital part of Europe's top-class thoroughbreds.
- The gene pool of horses with the soundness and stamina to compete over longer distances will suffer.
- A vital part of the attractive lure for investment, particularly from overseas, will be lost.
- Significant investment through yearling sales, particularly Tattersalls October Book 1, could be lost.
- The number and quality of sires and mares capable of breeding National Hunt progeny will decline



Overview

Current Status

- There are 27 staying races (12½ furlong plus) in the British stakes programme, which makes up approximately 9% of the Black Type programme.
- The British stakes staying programme seems well balanced, with races from 12½ furlongs through to 20 furlongs, including 205 races of Class 4 and above.
- Staying Patterns races make up a small proportion of the stakes programmes of leading racing nations outside the European Pattern.

Britain's Staying-Race Programme

- Although the Queen's Vase comes early in the three-year-old season, there are no conditions races for three-year-old before or after Royal Ascot.
- All three three-year-old-only Class 2 handicaps are run on Northern racecourses. There are no maidens or races restricted to fillies in the three-year-old-only division.
- Most of the leading, and valuable, staying handicaps are open to three-year-olds and up.
- The first staying handicap of the season open to three-year-olds and up is the Northumberland Plate. No three-year-old has run in the race for last ten years and the last three-year-old winner of the Northumberland Plate was Archduke Ferdinand in 2001.
- There are three fillies-only races in the three-year-old and up division and all are stakes races.

Britain's Staying-Race Pattern

- The annual ratings for the 2012 and 2013 runnings of the St Leger were below European Group 1 requirements. Annual rating of the 2014 St Leger on par with EPC Gr 1 requirement
- The Bahrain Trophy (Gr 3) enjoyed strong annual ratings from 2006-11, when field sizes were strong. Small field sizes appear to have contributed to the fall in annual ratings in 2012 and 2013.
- The Geoffrey Freer Stakes annual ratings have proved to be well above the European Group 3 requirements.



- The Queen's Vase recorded a good mark in 2014 (108.75), however, downgrading to Listed status resulted from placed horses not being good enough to keep the race at required Group 3 level, despite its attracting large fields.
- The River Eden Stakes, the only three-year-old up fillies & mares Listed race, has attracted strong field sizes since its introduction in 2006, with 12 runners on average per year.

2014 European Stakes Race Calendar

- Both the English and Irish St Legers (Gr 1) are held over the same weekend.
- The British Champions Long Distance Cup, which has been promoted to Group 2 status for 2014, was run the weekend before Longchamp's Prix Royal-Oak (Gr 1).
- The percentage of high-class stayers (Extreme) with a Group 1 performance rated 115 or over in the WTR rankings has fallen from 5.3% in 2009 to 3.8% in 2012 and 2013, with a low of 3% in 2011. WTR 2014 percentage of extreme performances was 4.3%

Sires

- There has been a 17% increase since 2005 in the number of GB-based stallions who sire 50% or more of their three-year-old-plus winners over 5-7 furlongs.
- There has been a rise of 55% in the number of stallions at stud in GB who sired 4.9% or less of their three-year-old-plus winners over 11-12 furlongs.
- Proven staying sires in Britain are in decline; they are being retired and exported, while young promising staying sires are, on the whole, covering small books of mares.
- Irish-based Sadler's Wells-line sires have dominated staying stakes races.
- 53% of staying stakes winners in Britain from 2004-13 were bred in Ireland.
- It is hard for commercial stallion farms to stand sires who have strong stamina influences.

Trainers and Breeders

Leading stayers are trained in Britain.



Leading breeders of stakes-winning stayers have been dominated by either the large stallion/breeding operations or owner-breeders.

Sales and Exports

■ More than 50 individual stakes winners bred in Europe have won over 9 furlongs or more for Australian-based trainers since 2011.

National Hunt

The majority of leading National Hunt stallions have been high-class middle distance or staying performers.

History





History

British racing has a long history of staging staying races. A number of Britain's staying races, run over 12 furlongs plus, originate in the late 18th century as some of the oldest races of the British turf.

The Doncaster Cup was first run 1766 over four miles, before being shortened to two miles and five furlongs in 1825. In 1891 it was again shortened to today's distance of 2 miles and two furlongs (18 furlongs). The great Eclipse, who raced between 1769 and 1770, won his nine races over distances between two and four miles.

The oldest English Classic, the St Leger, was first run in 1776. The first Derby was run three years later.

The Gold Cup was first run in 1807, while the following year saw the first running of the Goodwood Cup, which too was over an extended distance of three miles. The Park Hill Stakes, one of the three staying races restricted to fillies, was first run in 1839. The Jockey Club Cup (now the British Champions Long Distance Cup) was first run 1873, over a distance of two and a half miles. The Yorkshire Cup was first staged in 1927.

The Staying Question

The staying debate was raised in the 1980s and the early 1990s. In 1990 the Flat Race Pattern Committee discussed the future and reductions of distances of the Cup races – Gold Cup, Doncaster Cup and Yorkshire Cup - which was never carried out. However, the commissioned paper did conclude "there is every indication that this category, which is so much a part of our racing scene, will suffer an inexorable decline unless immediate steps are taken to arrest such a process." British racing was not keen to follow the example of North America, which had seen such as the Jockey Club Gold Cup reduced from 16 furlongs to the current distance of 10 furlongs within the period 1975-90.

The motion that the Cup races, such as the Gold Cup, should be reduced to 16 furlongs, was dropped by 2004.

On the lesser staying races, it was felt that field sizes were too small for satisfactory betting turnover. There was also little demand to increase the number of extended-distance maidens, but it was suggested there should be "three or four valuable 14 furlong maiden races introduced in various parts of the season."

The 1990 paper also devised the idea of a three-year-old Listed staying race to run as part of the Newmarket's July meeting, which was to become the now Group 3 Bahrain Trophy, to follow on from the Queen's Vase.

It was also recognised that the leading British stayers were a strong source of National Hunt stallions.


It was concluded that "little progress will really be made until owners and breeders have confidence in the future of the staying horse." The 1990 report also recommended that every suitable racecourse should run a least one 12 furlong plus race, which would have increased the number of staying races by 30 in a season.

A graduation programme was recommended, as the link between Flat and National Hunt racing was indispensable.



In 2002 there was a concerted effort to get a number of staying Cup races upgraded to Group 2 status, against the European Patterns Committee's objections. However, it was pointed out that the British staying Pattern was then the strongest in Europe and as a result British-trained horses supported most of Europe's leading staying races. Moves were made to upgrade the races concerned - *Henry II Stakes, Doncaster Cup, Lonsdale Stakes and then Jockey Club Cup - to Group 2 status. Both the Henry II Stakes and Doncaster Cup were upgraded for 2003 while the Lonsdale Stakes (Cup) became Group 2 in 2004.






Current Status

The staying programme makes up a significant part of the 2014 international Pattern. This is very much led by European dominance, headed by Britain, which was scheduled to stage 27 staying races making up the 9.3% of the 289 stakes races held in 2014. France's 23 black-type staying races make up the largest percentage of staying races to all stakes races at 9.6%. Ireland is next with eight races making up 6.9% of their stakes programme. Although Australia has the third largest number of staying races, it makes up just 3.4% of their stakes race programme. The staying programme in the US has all but vanished.

MAKE UP OF INTERNATIONAL 'BLACK-TYPE STAYING RACES 2014






Stakes Programme

Britain's staying stakes programme is the strongest and most balanced, with 27 races run over a variety of distances from 12½-20 furlongs, allowing stayers to develop in trip. The majority are run over distances of 14 furlongs (25%) and 16 furlongs (29%). France run the majority of its races over 12½ furlongs (34%) and between 15 and 15½ furlongs (52%). Six of Ireland's races are run over 14 furlongs, which makes up 75% of their staying stakes races. The majority of Australia's staying stakes races are run at the distances of 12½ (38%) and 16 furlongs (28%). Japan joins Britain and France in being the only countries that run stakes races beyond 16 furlongs. Britain runs the Doncaster Cup (Gr 2) over 18f and the Gold Cup (Gr 1) over 20 furlongs. France's longest stakes race is their Prix Royal-Oak (Gr 1) over 20 furlongs, while Japan holds the Diamond Stakes (Gr 3) over 17 furlongs.

Stakes Programmes – 2004-14

Britain and France are the only countries to have retained their staying stakes programme over a ten-year period. Britain's percentage of staying stakes races to total stakes races has remained at just above 9%, while France's is a few percent higher. There was an increase in Japan's total number of stakes races between 2004 and 2009, as they became a member of Part I of the International Cataloguing Standard in 2007. The US increased its staying stakes programme between 2004 and 2009 by 0.3%. However, numbers of staying stakes races in both Japan and the US declined between 2009 and 2014, despite Japan's overall stakes programme have recently increased slightly. The US has all but abandoned its attempt to have a stakes staying programme and abolished the Breeders' Cup Marathon (Gr 2) in 2014, due to the quality of previous years not being in keeping with other Breeders' Cup races. This leaves the US with just two staying stakes races; the 14-furlong San Juan Capistrano Handicap (Gr 2), run on Santa Anita Park's turf tack, and the American St Leger (L), also run on turf at Arlington Park.

Ireland and Australia are the only countries to have increased their staying stakes programme in the last five years, but are some way from achieving the programme that Britain and France have in place. With the Melbourne Cup now among the 50 top-rated Group 1 races in the world, it seems that Australia is making solid attempts to strengthen its staying stakes programme.

Britain's Race Programme

A total of 205 races, of Class 4 or above are scheduled to be run over 12 furlongs 50 yards or more, as part of the BHA's 2014 fixture list. A copy of all Class 4 or above races run over 12 furlongs 50 yards or more in 2014 is at the back of this study.

The first three-year-olds-only handicap over a greater distance than 12 furlongs is the Class 4 Mezzanine Handicap Stakes, run on 22 May at Sandown in 2014 with eight runners.

Although the 16-furlong Listed Queen's Vase, which was downgraded from group 3 in 2014, comes early in the season, there are few opportunities for three-year-olds to step up in trip before Royal Ascot. There is no conditions race for three-year-olds before or after Royal Ascot.

The 13-furlong Bahrain Trophy (Gr 3), currently on the 'at risk' list of being downgraded, is the year's second staying stakes for three-year-olds, held at Newmarket in mid-July.

A total of 16 Class 4 handicaps are spread over the season. The five Class 3 handicaps are all between the beginning of June and the end September, while all three Class 2 handicaps are over 14 furlongs with one each in July, August and September, and all at Northern racecourses - two at Haydock Park and one at York. The most valuable three-year-old-only staying handicap is the Melrose Handicap, run over 14 furlongs at York's Ebor meeting, with a total prize fund of £85,000.

There is no race restricted to fillies in the three-year-old-only division.

Most of the leading, and valuable, staying handicaps are open to three-year-olds and up, headed by the Ebor Handicap, over 14 furlongs and with a total prize fund of £265,000. The average field size for the Ebor Handicap from 2004-13 was 18.9. Since 2010 there has been no three-year-old runner.

The second most valuable staying handicap is the 18-furlong Cesarewitch with a total value of £250,000. The average field size between 2004 and 2013 was 32.8, with an average of 1.4 three-year-olds. The last three-year-old to win the Cesarewitch was Darley Sun in 2009.

A total of 80 races are scheduled for three-year-olds and up of Class 4 and above. The only maiden race over an extended 12 furlongs was run at Musselburgh on 20 April. It had six runners and was won by the Mark Johnston-trained Alex My Boy, who went on the run eighth in the King George V Stakes (Handicap) at Royal Ascot over 12 furlongs, and has won a further twice.

Thirty one of these are Class 4 handicaps, run over an extended 12-16 furlongs and staged throughout the summer. The 16 Class 3 handicaps run from July to the end of October. They are evenly balanced between Northern and Southern racecourses. A few similar races are scheduled close together.

Class 2 handicaps begin with the 16-furlong Northumberland Plate, which is open to three-year-olds and up and run on the last Saturday in June. No three-year-old has run in the race for last ten years, and the last three-year-old winner was Archduke Ferdinand in 2001. The Northumberland Plate, which has become the most valuable 16-furlong handicap of the year, attracted an average field of 18 from 2005-14. Class 2 staying handicaps are staged evenly until the end of the year. There is just one Class 2 conditions race over an extended 14 furlongs at the beginning of August, before the late-summer and autumn Cup races.

There are three fillies-only races in this three-year-old and up division, all stakes races: the Park Hill Stakes (Gr 2), Lillie Langtry Stakes (Gr 3) and EBF River Eden Stakes (L).

The majority (77%) of four-year-olds and up races are held before three-year-olds are able to take on older horses (the last weekend in June in the Northumberland Plate). 56% of these races are run at Class 4 handicap level, with just 28 handicaps at Class 2 and 3 levels.

There are five Class 2 conditions races. Only one is run on turf, the Queen Alexandra Stakes, the closing race of Royal Ascot over 21 furlongs. The other four are run on the all-weather before April and include the valuable (£150,000 total prize fund) Marathon Stakes (15½ furlongs), created for the inaugural 2014 All-weather Championships, run on Good Friday.

There two just two fillies-only races for four-year-olds and up, both Class 4 handicaps run in June and July.



British Owners and Breeders Incentive Scheme (BOBIS)

BOBIS (the British Owners and Breeders Incentive Scheme) is open to the winners of all Class 2-4 maidens, nurseries, three-year-old-only handicaps and conditions races and Class 5 two-year-old fillies' maidens in Britain. A £10,000 prize fund has been awarded to winners of novice races and class 2-4 fillies-only races.

Under these criteria, only staying races for three-year-olds are eligible. Excluding Class 1 (stakes) races, this leaves 24 staying races, from a total 205, eligible for BOBIS Scheme payments of £6,000 per race. There is no opportunity for staying fillies to win a £10,000 prize for winning a Class 2-4 fillies-only race.

The amalgamation of BOBIS and the Racing Post Yearling Bonus Scheme to form Plus 10 in 2015 means the incentive programme will change.

Conclusions





Conclusions

Although Britain's staying programme is one of the strongest in world and makes up an important part of the sport's heritage, there has to be concerns that the British stayer is in decline. With a substantial number of small British breeders running their operations at a loss, it is inevitable that the more precocious sires will dominate. As long as Britain's two-year-old programme is one of the strongest and busiest in the world, it is not surprising that speedy sires dominate, allowing investors a quicker return on the track, thus giving commercial breeders a better return. Britain's leading stallions, who are capable of siring high-class stayers, demand high stud fees, which only cash-rich breeders' can afford. This has led to lesser sires standing in Britain with staying influences having far lower appeal in the heavily dependent commercial marketplace. In turn, there has been a decline in the three-year-old stayer, which has contributed to the downgrading to Listed level of the Queen's Vase by the European Pattern Committee, and the Bahrain Trophy (Gr 3) being placed on the 'at risk' list in 2014.

With National Hunt breeding so reliant on top-class, smart middle-distance and staying performers, there will, in time, be drastic implications for National Hunt racing, which makes up a large proportion of the British and Irish racing industries.

Is this situation reversible?

Although the leading stayers in Britain have been dominated mostly by the Irish-based Sadler's Wells sire line, there need to be more incentives to encourage British stallion studs to stand and breeders to use sires capable of producing high-class stayers. Since Britain no longing stands such as Halling, Singspiel and Rainbow Quest, there has been little to suggest that these sires have successors.

British racing must consider incentives to owners to race and keep stayers in training in Britain. Of course, owners cannot ignore expensive sales to overseas interests, but to secure the future of the British stayer well-bred horses with the potential to be successful stallions need to be encouraged to remain in training in Britain.

Although the British staying-race programme looks well balanced, a few adjustments could be made to the Pattern and other races. Examination of the placement of the St Legers (Gr 1) in Britain and Ireland and the timing of the British Champions Long Distance Cup (Gr 2) and the Prix Royal-Oak (Gr 1) are two instances. Ireland's Qualified Rider (QR) races are a popular way of both Flat and dual-purpose and National Hunt-bred runners competing against each other on the Flat. While these are mostly used as educational races for aspiring National Hunt performers, they do allow otherwise dual-purpose-bred performers to emerge as stayers. Examples include Missunited (by Golan), winner of the Lillie Langry Stakes (Gr 3) in 2014, who won a QR race in 2012. While the amateur-rider programme in Ireland is considerably different from Britain's, staging staying conditions and maiden races for dual-purpose-bred horses could create an opportunity for more stayers in Britain.

More opportunities for fillies and mares races might also be considered, particularly in order to encourage more staying mares in Britain's broodmare population.

The 2014 British staying Pattern produced some high-class performances. The British-bred and trained Cavalryman (by Halling), as well as winning the 12-furlong Princess of Wales's Stakes (Gr 2), beat stablemate Ahzeemah (by Dubawi) in the Goodwood Cup (Gr 2), and Leading Light (Montjeu) stamped himself as a top-class stayer by winning the Gold Cup (Gr 1), with the filly Estimate a fine second. Without concerted effort in preserving the staying breed, it will become increasing difficult for the status and history of leading Cup and staying races to maintain their prominence.

As Federico Tesio pointed out in *Breeding the Racehorse*, first published in 1958. "If we raced ten sprinters against each other in a 2½-mile race, one is bound to finish first, but this does not make him a stayer."



Consequences of Decline

If the British breeding and racing programmes for stayers are allowed to decline, the consequences will be serious.

Diversity

British racing's diversity, for which it is world renowned, would be seriously jeopardised.

Spectacular horseracing events from Cheltenham to Royal Ascot and Aintree to Epsom have been founded on staying races that are part of British racing's heritage and vital to its continued success.

Pedigrees

There will be an adverse effect on the families and pedigrees that make up a vital part of Europe's top-class thoroughbreds.

If there are not suitable opportunities for top-class stayers to win over extended distances, breeders will be forced to use speedier sires, and in time they will breed out the staying ablity from these Classic ad smart families, which have been crucial to British racing and bloodstock over the years. This will affect owner-breeders, who in order to keep their families strong rely on racecourse success, particularly via fillies' races such as the Park Hill Stakes (Gr 2) and Lillie Langtry Stakes (Gr 3).

As described in the study, there have been notable exports of potential and proven stayers to Australia, to balance that country's lack of a breeding programme for stayers. British racing could eventually find itself in similar position and thus relying on other European countries, such as Ireland, France and Germany, to supply stayers.

Soundness and the Gene Pool

The gene pool of horses with the soundness and stamina to compete over longer distances will suffer.

Although there is little prospect that the Sadler's Wells sire-line will be bred out soon, it could become a speedier influence, as it is bred to speedier mares. Galileo's sons Teofilo, New Approach and Rip Van Winkle have already sired Group 1-winning juveniles, having themselves been Group 1 winners over 10-12 furlongs. If there are not the type of high-class staying races that these Sadler's Wells/Galileo sire-lines have thrived on over recent years, the line will become speedier, as has happened in the US with most of the Seattle Slew-line sires.

Investment

A vital part of the attractive lure for investment, particularly from overseas, will be lost.

British racing has one of the most attractive models in the world. The Pattern programme, history and prestige, as well as the diversity of racecourses and well-balanced, historic race programme, have attracted an impressive amount foreign investment that has become vital for the success of the sport over the last 20-30 years. The Maktoum family, their associates (such as Rabbah Bloodstock), Khalid Abdullah and other members of the Saudi royal family, and George Strawbridge from the US, as well as more recently branches of Qatar's Al Thani royal family, acquired their passion for the sport from racing horses in Britain. All have had significant success with stayers and have played a vital part in keeping the staying programme strong. Darley (Godolphin), Shadwell and Juddmonte Farms have had



considerable success as both breeders and owners of stayers and have also stood sires cable of producing smart stayers. More recently Sheikh Fahad of Qatar Racing and Pearl Bloodstock, owned Dunaden, winner of the Melbourne Cup, and he has retired as a dual-purpose sire for 2015.

Yearling Sales

Significant investment through yearling sales, particularly Tattersalls October Book 1, could be lost.

Turnover at the British yearling sales in 2013 was more than £132 million. Tattersalls Book 1, which alone generated approximately a third of this total, has become arguably the strongest yearling sale in the world in recent years. Its select catalogue is dominated by yearlings bred by Classic sires out of some of Europe's leading families, and breeders of these well-bred yearlings rely heavily on the current staying-race programme to keep these Classic families active and strong. The leading lots in Tattersalls Book 1 in 2012 and 2013 were dominated by the Sadler's Wells sire-line via such as Galileo, Montjeu, New Approach and Teofilo. Although other leading sires, such Sea The Stars, Dansili and Dubawi, are capable of producing high-class, middle-distance and staying performers, often via Sadler's Wells-line mares, it is imperative that these families and sires are allowed to stay strong through the staying programme. Graduates from Tattersalls Books 1 & 2 in 2012 include the winners of the 2,000 Guineas, Derby and St Leger in Britain in 2014 - Night Of Thunder (by Dubawi), Australia (by Galileo) and Kingston Hill (by Mastercraftsman) respectively. With Britain's other yearling sales leaning towards speedier-bred yearlings, it is important that British bloodstock and the vast investment in it is maintained at its current status through a strong staying-race programme.

National Hunt

The number and quality of sires and mares capable of breeding National Hunt progeny will decline.

The loss of top-class stayers would have a drastic affect on the National Hunt breeding programme. Not only would there be a sharp drop in potential National Hunt and dual-purpose sires, the National Hunt broodmare population, in which stamina influences are so important, will be damaged. If the leading stamina influenced sire lines are allowed to 'speed up', this too will have implications on the National Hunt breed that could be irreversible.

The National Hunt breed is not all that will suffer, The Levy Board's financial contribution to British racing, of which National Hunt makes up 40%. Would be at risk. British racing already faces an increasing number and range of gambling opportunities, and any loss of National Hunt racing would jeopardise vital revenue.



The Gold Cup, over 20 furlongs, is the longest staying Pattern race held in Britain. It is also the first staying Group 1 of the European Pattern.

The Gold Cup has fallen below the Group 1 Pattern requirements of 115 for the last two years. Although the 2012 event only just fell below, that in 2013 was well short, and because the winner Estimate was entitled to the 5lb fillies' allowance, she was rated only 108.

2014 renewal saw the race gain a rating of 116, which falls within the Group 1 EPC requirements






The Gold Cup ratings were well up to standard for a Group 1, but the last two years have seen below par rated fields. As the 2013 winner, Estimate, was a filly, this brought the 2013 average well below the 115 Gr 1 requirements.

The average eleven-year race rating is 114.72.

For the years 2006, 2007 and 2008 an official rating was not given for one of the placed horses. Rating was divided by three for the rating obtained.






Over the last three years the St Leger has fallen well within the Group 1 Pattern requirements. The winner and the second in both 2013 and 2012 were high-class horses. Encke beat Camelot, who was trying to complete the British Triple Crown, having won the 2,000 Guineas and Derby. The 2013 winner Leading Light, who previously won the Queen's Vase and beat the 2013 Oaks winner at Doncaster, went on to win the 2014 Gold Cup over 20 furlongs. The 2014 winner Kingston Hill, is a high-class performer having been second in Derby, but rest of the field below Gr 1 standard average.



2014 was won by Estimate, who not only is a filly, but was having a weaker season than the previous year.





The annual ratings of the Goodwood Cup over the last three years have remained consistent for a Group 2. The Park Hill Stakes, the leading staying race restricted to fillies and mares, is held during Doncaster's St Leger meeting in mid-September. 
Since 2011, when the race was renamed and moved to British Champions Day, ratings for the British Champions Long Distance Cup have risen substantially.

Between the years 2004 to 2010 the race was run as the Jockey Club Cup, at Newmarket.

Annual Ratings - The 2014 race posted the weakest rating since 2011, not helped by the heavy going which lead to many of the leading candidates to run below par. The winner, Forgotten Rules, was an unexposed four-year-old, running only for the third time.


The Bahrain Trophy, run in mid-July, is the second stakes race of the season for three-year-olds only after the Queens Vase, The 2014 race received a timely boost, with the first three proving to be smart three-year-old stayers' and all ran with credit in the St Leger (Gr 1).

The race produced substandard races in 2012 and 2013. The Bahrain Trophy, which was only upgraded to Group 3 status in 2009, is often targeted by unexposed, progressive three-year-old middle-distance/stayers and can be used as an early St Leger trial.

All three winners between 2011 and 2013 were trained by John Gosden.







From 2004 to 2011 the Henry II Stakes was run as a Gr 2, and from 2012 as a Gr 3. There was no rating for the 4^{th} placed in 2004, when the rating was divided by three for the rating obtained.

Field sizes in 2006, 2007 and 2011 were small, which contributed to the low rating achieved for the-then Group 2 Henry II Stakes. Since the race was downgraded to a Group 3, the field has numbered ten or more each year.

From 2004 to 2011 Henry II Stakes run as a Gr 2. From 2012 run as a Gr 3.


ANNUAL RATINGS STAYING GROUP 1'S 2004 - 2014

Although the 2013 Gold Cup's rating is not a ten-year low, this is the first time two annual ratings in a row have been below the European Pattern Committee's Group 1 requirements. In 2014 The Ascot Gold Cup recorded its highest rating since 2008




ANNUAL RATINGS STAYING GROUP 2'S 2004 - 2014



The Group 2 staying races have held up within the 110 annual rating set by the European Pattern Committee. The only race to fall well below was the 2013 Park Hill Stakes, where the fourth-placed horse was rated below 100. On the whole the 2013 races had lower annual ratings to those of the previous two years. The Long Distance Cup/Jockey Club Cup ratings (Gr 2 in 2014) and Doncaster Cup fell to below Gr 2 level in 2014.

The annual ratings for Britain's staying Group 3s have fluctuated much more than in the other Groups over the last ten years. However, 2013 was the first year since 2009 to have three races below the Group 3 parameter of 105. All Group 3's were above the 105 level in 2014.



WORLD'S LEADING GROUP 1 RACES


Of the world's top 50 three-year-old-plus Group/Grade 1 races, on an average of a three-year annual rating between 2011 and 2013, only two staying races qualified. As you would expect, most of these races are run over 8-12 furlongs. Only two races are over 12 furlongs-plus - the Melbourne Cup, ranked joint 43rd, and the St Leger, joint 48th.

The Melbourne Cup is in fact the only handicap in the top 50 races, and the first four places in both 2012 and 2013 went to European-bred horses. This raises questions: are Australian trainers better at training stayers than their European compatriots, or are they being overrated compared to European stayers, or is it a better race?

ANNUAL RATINGS STAYING LISTED RACES 2004 - 2014




The Grand Cup, Stand Cup the River Eden Stakes were first run as Listed races in 2006. The Noel Murless Stakes was moved from Newmarket to Ascot in 2011. Queens Vase was demoted to Listed status, from a Gr 3 in 2014

The staying Listed races have remained on a par with previous years. The strongest races are the Aston Park Stakes, Jockey Club Rose Bowl and March Stakes. The weakest races are the Chester Handicap, Further Flight Stakes and the River Eden Stakes, run on the all-weather at the end of the season. The Queen's Vase has seen a decline since 2011, although 2014 saw a dramatic improvement in its annual rating.

Races such as the Aston Park Stakes and March Stakes used as trials, either for bigger Summer targets or Melbourne Cup preps runs.



ANNUAL FIELD SIZES STAYING LISTED RACES 2004 - 2014



The Grand Cup, Stand Cup and River Eden Stakes were first run as Listed races in 2006. The Noel Murless Stakes was moved from Newmarket in Ascot in 2011.

The River Eden Stakes run in November on Lingfield's all-weather surface for three-year-old and up, fillies and mares, has attracted the strongest field numbers, with ten or more runners, since it was made a Listed race in 2006. The Listed handicaps, the Chester Handicap and Silver Cup, run at York, have proved to be popular with trainers and both attracted good field sizes over the six years. York's Grand Cup, which failed to attract good sizes of field numbers when run at Musselburgh in 2006 and 2007, has declined to five runners in each of 2012 and 2013. Both the Aston Park Stakes and March Stakes, which are held on grade one Southern racecourses, Newbury and Goodwood respectively, have never attracted particularly large field sizes but have returned strong annual ratings. Grand Cup Stakes, attracted a good field in 2014

There were 58 staying Pattern races (12 furlongs plus) scheduled to be run in the leading European countries (Britain, Ireland and France) in 2014. These are run between February and mid-November. A number are staged very close together. These include two 14-furlong races run within two days of each other. Due to



Navan's Vintage Crop Stakes being promoted to Group 3 status for 2014, it is now run two days after the Yorkshire Cup (Gr 2), with the Listed Aston Park Stakes on the day in between.


Also in close proximity are the Prix Vicomtesse Vigier (Gr 2) and the Henry II Stakes (Gr 3), run within four days of each other.

With the Queen's Vase Stakes having been demoted to Listed status in 2014, it now run three days before Chantilly's Prix La Moskowa (L). Both are over a similar distance and restricted to three-year-olds.

Although the formation of the Irish Champions Weekend did not involve a change of date for the Irish St Leger (Gr 1), it resulted in two large race meetings being run over the same weekend, both with Group 1 staying races. Although Doncaster's St Leger (Gr 1) is restricted to three-year-olds, the Irish St Leger is also open to three-year-olds, and runners from this age category have performed well over the last four years.

The other big-race clash involves the British Champions Long Distance Cup Stakes, which has been promoted to Group 2 status for 2014, and is run on the weekend before Longchamp's Prix Royal-Oak (Gr 1), over half a furlong shorter. Both races are open to three-year-old and up and have prizemoney funds of more than £275,000.

There are also two Listed races, both over 14 furlongs, that are run on the same day - Newmarket's Noel Murless Stakes, for three-year-olds only, and the Prix Scaramouche at Saint-Cloud.

World Thoroughbred Ratings 2008 – 2014






DISTANCE CATEGORIES OF THE WORLD THOROUGHBRED RANKINGS - 2008 to 2014


PERCENTAGE OF DITANCE CATEGORIES OF WTR 2008 - 2014


COUNTRIES OF TRAINERS OF LEADING WTR'S STAYERS 2008 - 2014






There are more sires responsible for more 5-7-furlong winners in 2014 than in 2005. Although the 10% to 29.9% category of 5-to-7-furlong winners has risen from six sires to eight, the 0% to 9.95% and 30% to 49.9% categories have fallen, of which the latter has fallen by 66.6%







This is confirmed by both the number of sires producing 5% to 9.9% and 10% to 19.9% winners decreasing by 25%. The number of sires producing 20% plus of their winners over 13 furlongs-plus remains unchanged

(Sires of 3 crops or more in 2013 only standing for more than £2,500 in 2013 3yo career plus winners in GB/Ire only to the end of 2013)




Of the 17 leading sires (7% plus) of career 13-furlong-plus winners that were standing at stud in Britain in 2013, eight commanded an advertised 2014 fee of £9,000 or less (nine, if you include Sakhee). The young promising staying sire Authorized was exported to France, where he will receive more opportunities to cover bigger books of mare, while Notnowcato, has entered the National Hunt breeding roster in Ireland. A further two sires have been retired, including Britain's leading staying sire Halling, resulting in a total decrease of 17.6% in sires standing at stud in Britain in 2014 with 7% or more of their winners winning over 13 furlongs or more.

Although Dubawi (7.7%) and Dansili (7%), Britain's two leading proven sires, have sired at least 7% of their career winners over 13 furlongs or more, it is clearly difficult for commercial stallion farms to stands sires that have strong stamina influences.

Comparing the leading sires of 13-furlong-plus winners against mares covered between 2011 and 2014 confirms that it is harder to stand commercial sires that have strong stamina influences. Olden Times covered only 22 mares in 2011 and 2012, while Kayf Tara is a leading National Hunt sire. Sulamani has made a strong start as a staying sire and covered a healthy book of 93 mares in 2011, his first season at Yorton Farm Stud, where he was standing for a fee of £2,500, after previously having stood at Haras du Logis. Other sires capable of producing winners over 13-furlong-plus, such as Nayef, Rail Link and Sakhee, all suffered a decrease in the number of mares they covered between 2011 and 2014 as their offspring show they can stay further than the commercial market demands.

Medicean, who has a 9.4% career record for 13-furlong-plus winners, and his mare numbers increased in 2013, but decreased in 2014.

Cacique, who has made a strong start as a sire, returned to covering duty in 2012 and but due to fertility management had his book limited.

Sir Percy, who has 8.8% of 13-furlong-plus career winners, has received two strong books of mares, but suffered a sharp drop in the number of mares he covered in 2013/2014.



Young Flat Sires

There are a number of young sires not included in the above tables due to having had fewer than three crops of racing age in 2013. The list below comprises stallions who have retired since 2009 having won over 10 furlongs or more, so could have the potential to sire winners over staying distances. Sires with a 2015 advertised stud of £2,500 or more included.



Suffix after sires equals country where stood / * = active sires



Irish-based sires from the Sadler's Wells sire-line have dominated the staying division of stakes winners over the last ten years. The majority of leading sires of staying stakes winners over such a period are likely to have ended their stud careers, and of these ten only Galileo, Cape Cross and Dansili are still at stud. All ten have stood at just four different stud operations. Of the 209 staying stakes winners between 2004 and 2014, 9.5% have come via Galileo, while three of the leading sires that have stood or are standing at Coolmore make up 25% of the staying stakes winners between 2004 and 2014. Darley Stud Management, which has stallion stations in Britain and Ireland, had or have Halling, Singspiel, Cape Cross and In The Wings on their rosters. The British-based Juddmonte Farms stands Dansili, as well as having stood Rainbow Quest. Kirsten Rausing's Newmarket-based Lanwades Stud stood Selkirk, who like Halling is from the Sharpen Up sire-line. All four of these breeding operations have supported their own sires and race their progeny. Dalakhani is an emerging staying sire and the late Dynaformer has proven to be leading staying influence from the US.

(Figures taken at the time of covering of each stakes winner)




Of the 209 British staying stakes winners between 2004 and 2014, 108 (53%) were by sires standing in Ireland, and 63 (30%) by British-based sires at the year of covering. There were four stakes winners (2%) from UAE, sired by Halling, who stood there for the 2004-06 breeding seasons. All four of Halling's UAE-sired stakes winners were bred by Darley. American-based sires make up 11% of the stakes winners.

Statistics Weatherbys Facts Book 2007 to 2013

There has been a decline is the number of stallions at stud Britain since 2006. The biggest decline has been among dual-based sires, whose numbers have fallen by 69% since 2006. There were 68 registered Flat sires in 2013, an increase of two from 2012 but still a 37% decrease from 2006. Although there was a peak of 22 National Hunt sires in 2010, the number had declined to an eight-year low of 13 in 2013.



LEADING BREEDERS OF INDIVIDUAL STAKES WINNERS 2004 - 2014




The list of leading breeders of British staying stakes winners between 2004 and 2014 has been dominated by either the large stallion/breeding operations or owner-breeders. Darley Stud Management is the leading breeder of staying stakes winners in Britain with 17 individual stakes winners, of which ten were by its own sires. The British-based Juddmonte Farms have bred seven stakes winners, all of which were raced by Khalid Abdullah. Newsells Park, which operates as a commercial operation, has bred six stakes winners, of which two were retained and four were sold. British-based owner-breeder Philippa Cooper (Normandie Stud) has produced four stakes winners in recent seasons and Lady Bamford has bred five staying stakes winners.

Although Aidan O'Brien trained 17 individual staying stakes winners between 2004 and 2014, the remaining leading trainers of British staying stakes races are based in Britain.


Therefore, the Tattersalls Autumn Horses in Training Sale can offer investors an opportunity to obtain proven and potential stayers either to race under National Hunt rules or abroad. With the Australian breeding industry unable to produce high-class stayers to support its valuable staying programme, this led to Australian investors spending more than 2,500,000 guineas at the 2013 sale and does not include many of the horses bought privately.

These increasing Australian investments, both at auction and privately, have led to an increase in European-bred horses winning 9-furlong-plus Australian stakes races, with 23 individual stakes winners over 9-furlong-plus in 2013. In 2014 there were 15 stakes winners in Australia over 9 furlongs or more. There have been 59 individual stakes winners bred in Europe over 9 furlongs or more for Australian-based trainers, with 18 accounting for 24 Gr 1 races. These included two recent Melbourne Cups - three if you include 2011 winner Dunaden, trained by Mikel Delzanges in France. Australia's second 16-furlong Group 1, the Sydney Cup, was also won in 2014 and 2013 won by European-breds - The Offer, a graduate of Tattersalls Autumn Horses in Training Sale, and Mourayan respectively. German-trained Protectionist, the fourth Euro bred Melbourne Cup winner in as many years; also other Euro trained Gr 1 winners include 2013 L.K.S. Mackinnon Stakes winner Side Glance and the Aiden O'Brien-trained Cox Plate winner Adelaide.

The majority of leading National Hunt stallions have been high-class middle-distance/staying performers, as demonstrated by the list below of the 2012-13 leading National Hunt sires who were stakes winners over 12 furlongs or more. It is crucial for National Hunt industry that a high-class staying programme is maintained.

While some of the above names are no longer at stud, the majority of the 35 sires listed were retired as dual-purpose or National Hunt sires. Only seven (20%) retired to stud in Britain, while 15 (43%) stand in Ireland. As one would expect, the Sadler's Wells sire-line dominates, with 19 sires (54%).

Although this list includes such as Conduit and Harbinger, who are currently standing as top sires in Japan, the majority of these very high-class performers have been marketed to the National Hunt market and have strong prospects of becoming successful sires within this sector.

National Hunt-Trained Runners

The majority of staying race runners are Flat-bred and Flat-trained, but high-class National Hunt-trained horses have run with credit in Flat staying stakes races in Britain. These are mostly horses who have run on the Flat previously, therefore becoming dual-purpose performers and are by Flat sires. Examples include the Yorkshire Cup (Gr 2) winner Percussionist (by Sadler's Wells), Kasthari (by Vettori), who won the Doncaster Cup (Gr 2), and Caracciola (by Lando), who won the Grand Cup (L), and who all raced on the Flat before becoming dual-purpose performers.

Ireland's Qualified Rider (QR) races are run over 12 furlongs plus, and provide an opportunity for both Flat- and National Hunt-bred horses to compete against each other. Often staged at the end of a Flat meeting, these races vary from maidens to conditions events. Although restricted to amateur jockeys and for three-year-olds plus, they offer National Hunt-bred and trained horses a chance to compete on the Flat against Flat-bred horses. Example of horses who have graduated from QR races include the Group 3-winning hurdler Missunited, winner of the Lillie Langtry Stakes (Gr 3), and the Listed-placed stayer El Salvador.
