Breeding Guide: Administration and Traceability

Supporting breeders with important information to fulfil their legal obligations as horse owners and keepers along with key deadlines for General Stud Book (GSB) registration processes.

If you are thinking about or are new to thoroughbred breeding, the Thoroughbred Breeders' Association (TBA) is here to support you with advice and guidance as you embark on this exciting journey. We will help you lay the foundations for sustainable breeding practices that will bring much enjoyment as well as a great sense of achievement in nurturing life-long bonds between you and the thoroughbred families you produce.

We hope the following information provides a helpful introduction to some of the key processes required. The TBA takes a proactive role in supporting breeders to maintain and exceed the highest possible standards of equine health and wellbeing on stud farms across Britain, including the provision of written guidance materials; educational events and resources; industry representation at Government level; and regular notifications on veterinary matters or regulatory changes.

For the industry, equine welfare is of the upmost importance and the fullest possible traceability is a crucial component of the thoroughbred sector's maintenance of its social licence to operate. The registration processes you will read about are vital to the industry in evidencing the location and person(s) responsible for thoroughbreds at all life stages.

In addition to the legislation which is applicable to all horse owners, there are the registration deadlines and requirements of the General Stud Book (GSB) maintained by Weatherbys, as well as the rules of the regulator, the British Horseracing Authority (BHA). We have included a timeline of some of these legal requirements, to ensure that as a breeder, you are not not subject to financial penalties; that the horse is not excluded from potentially profitable incentive schemes; or in extreme circumstances, that the horse is precluded entry from the GSB, thereby becoming ineligible to race.

Legal responsibilities of horse owners and keepers







The current Digital Identification and Traceability Policy Reform may bring about changing requirements. The TBA is working alongside Government with the objective of delivering simplified and workable improvements to the current equine passport system. It is a legal responsibility of the new owner to notify the Passport Issuing Organisation (PIO), which is the GSB at Weatherbys for thoroughbreds, of a **transfer of ownership** within **30 days** of any transaction taking place. Return the paper passport to Weatherbys for the record to be completed. It is also a legal requirement of the owner to raise a **deceased notification** with the PIO when a horse has died or has been put to sleep, which should be done within **30 days**. Forward the paper passport to Weatherbys for invalidation (it can then be returned to the owner if desired).

It is a legal obligation for all horses in Britain to be microchipped and to have a paper passport (by six months of age or before 30 November, whichever is later). For thoroughbreds, **foal notification** must be submitted with the GSB within **30 days** of birth and **foal registration** should be completed by 31 July (in order to secure the lower fee), which will ensure that the thoroughbred is eligible to race. The passport must accompany the horse at all times, i.e. when travelling.

The passport should be signed by the owner/keeper or the attending veterinary surgeon to indicate that the horse is not intended for slaughter for human consumption, which will ensure that the thoroughbred is eligible to be declared to race in Britain and that a range of **veterinary medicinal products** can be administered without having to be recorded in the passport.
