Terms and conditions 2017

- Horses must win or be placed at least once in an EBF Breeder's Fillies Series race (Not including the series races on 7th October) and then go on to win one of the EBF Breeders' Fillies Series races at Newmarket on 7th October.
- First, second or third finishing positions will constitute a placing in the series, irrespective of the number of runners under starters orders.
- Horses must be British bred – defined as a foal that was born in GB and carries a GB suffix – or must be sired by a British domiciled stallion at the time of covering.
- Horses must be owned by a current member of the TBA at the time of winning a race on 7th October 2017.
- The prize in the form of a voucher to the value of up to £25,000 can be redeemed against the cost of a nomination fee (advertised price) to a British-based stallion.
- The nomination can only be used on the qualifying filly and must be taken up in either the 2018 or 2019 GB breeding season. The voucher may also be used on the qualifying filly over two breeding seasons (2018 and 2019), for two separate nominations, that when combined, do not exceed a total advertised price of £25,000 (Minimum advertised nomination value must exceed £5,000).
- There is no cash redemption for the voucher.
- There will be no cash refund for any unused value of the voucher.
- The selected stallion nomination must agree to special live foal terms.
- The owner of the filly is liable to pay the VAT on the nomination(s).
- The TBA reserves the right to amend the scheme and its terms and conditions at any time. The TBA's decision regarding eligibility is final.
